

# Privacy Policy

Online Loan 24/7 ("us", "we", or "our") operates the [onlineloan247.com](https://onlineloan247.com) website (hereinafter referred to as the "Service").

This Privacy Policy sets out the manner in which we collect, use, manage and protect the data that is capable of identifying you as an individual whether on its own or in conjunction with other data accessible by us ("Personal Data") in compliance with the Personal Data Protection Act 2012.
